Where the COFR Operator is not the Owner then the owner details should be provided in the appropriate fields in Box 4.

**Important Information:** If the entity named as the vessel’s COFR Operator differs from the vessel’s Owner, then per OPA90 regulation § 138.100 – Non-owning operator’s responsibility for identification, subsection (a) “Each operator that is not an owner of a vessel certificated under this part, other than an unmanned barge, shall ensure that the original or a legible copy of the demise charter-party (or other written document on the owner's letterhead, signed by the vessel owner, which specifically identifies the vessel operator named on the Certificate) is maintained on board the vessel.”

Attached is a bridging letter template, which meets the requirement of § 138.100 – Non-owning operator’s responsibility for identification, although other documentation may also be acceptable.

- Box 5:** A requested COFR guaranty inception date should, wherever possible, be earlier than the anticipated date of entry of the vessel into US waters to avoid vessel detention.

A requested COFR guaranty expiry date will usually be considered by SIGCo only where the expiry date requested is the SIGCo common expiry date of the fleet through which the application is being made. Other than this, we do not offer terms for short periods.

P&I Club refers to the primary insurer of the vessel. SIGCo accepts all International Group Clubs, plus British Marine, Nord Nederlandsche, Korea P&I Club, Carina P&I, Hanseatic P&I, Raets Marine, Hydor and Lodestar where pollution coverage is \$500 million or greater. SIGCo reserves the right to refuse the risk if the pollution deductible is significant (with determination made on an individual basis).

- Box 6:** Only complete this section if you want SIGCo to process a CG5585 application on behalf of the COFR Operator. This is a free service offered by SIGCo and SIGCo will accordingly pay all associated application costs (certification fees, process agent fees etc) on behalf of the applicant with no further charge.
